



Burford Capital completes US\$400 million private offering with advice from Ogier

The 9.250% senior notes due 2031 are guaranteed on a senior unsecured basis by Burford Capital as well as Burford Capital Finance LLC and Burford Capital PLC, both indirect, wholly owned subsidiaries of Burford Capital.
