#### **Background and experience**

He also represents trustees, protectors and beneficiaries in relation to their rights under offshore trust arrangements, and shareholders of distressed funds in connection with disputes arising out, or in anticipation of, events of default or unpaid redemptions or capital calls.

Marc is part of Ogier's multi-disciplinary Restructuring & Insolvency and Private Equity teams. His achievements include advising on scheme of arrangements restructuring bond debt and other assets issued or held by various types of Cayman entity, facilitating the refinancing of

international oil and gas groups with offshore vehicles, bringing and defending large-scale fraud and asset tracing claims on behalf of liquidation estates, and assisting parties to onshore litigation by providing expert evidence and analysis of technical questions of Cayman Islands law.
