Are you ready for PRI reporting or considering becoming a signatory?

More than 5,000 investors worldwide are signatories to the UN Principles for Responsible Investment (PRI) and the numbers are growing worldwide.

The PRI are based on six core principles and comprised of 12 modules of mandatory and voluntary indicators. Pension funds make up to 50% of the signatories followed by insurers, sovereign wealth funds, endowments and foundations.

Are you ready for PRI reporting or considering becoming a signatory?

The content of the 2024 Reporting Framework has not changed significantly, but there is a list of items for asset managers and asset owners to consider before submitting their annual report:

- the PRI are centred around six core principles with the annual reporting comprised of 12 modules of mandatory and voluntary indicators
- every new signatory must publicly commit to the principles by a signed declaration from the
 organisation's CEO (or equivalent) pledging to incorporate environmental, social and
 corporate governance (ESG) issues into investment analysis, to be an active owner and to
 seek appropriate disclosure from investee companies on ESG issues and to promote
 implementation of the PRI's Principles within the investment industry
- becoming a member of the PRI also allows investment managers to publicly demonstrate their commitment to responsible investing

The 2024 reporting cycle

The PRI 2024 reporting window will open on 2nd May 2024 and will run for 12 weeks until 26th July

2024. Reporting is mandatory for signatories that have passed their grace period and did not submit a transparency report during the 2023 reporting cycle, or only completed it privately, and those that reported on a mandatory basis but did not meet the minimum requirements.
