

Simon advises on transactions in relation to investment structures, and on the formation of investment funds and structures across a broad range of asset classes, including hedge, real estate, private equity and digital assets.

He advises on multi-jurisdictional mergers & acquisitions; corporate finance; equity capital markets including listings of special purpose acquisition companies (SPACs) and joint ventures. His clients include international corporate and investment managers, banks and UHNWIs.

Simon is one of the leading BVI regulatory lawyers - from Jersey he frequently advises European based trust companies and financial services providers on BVI legal and regulatory matters. In particular, he advises on regulatory applications to the BVI Financial Services Commission arising out of financial services M&A and matters relating developments in the BVI's regulatory regime.
