He has represented Government on many complex public and private sector partnership negotiations including the Cruise Berthing Facility, Redevelopment of the Owen Roberts Airport, and the development of the Royal Water Tender Cruise Terminal with the Florida Caribbean Cruise Association.

As a former Minister of Tourism Cline has significant experience working with developers to negotiate concessions for new Tourism projects as well as acquisitions.

Cline was also involved in the negotiations of the agreements relating to the establishment of

Health City Cayman Islands and the Special Economic Zone regime as well as the development of the required legislative framework to implement those projects.

Cline has experience of working with the Government on initiatives with the Maritime Authority, and currently serves as Chairman of the Cayman Islands Port Authority and Deputy Chairman of the Mental Health Commission and regularly participates in various panels locally and internationally as a subject matter expert in his areas of expertise. He is also a Council Member of the Cayman Islands Legal Practitioners Association
