



## Ogier advises Eureka Acquisition Corp on SPAC IPO

Ogier in Hong Kong acted as Cayman Islands counsel to Eureka Acquisition Corp, a special purpose acquisition company, on its US\$50 million initial public offering on Nasdaq.

The Cayman incorporated special purpose acquisition company (SPAC) announced the closure of its initial public offering (IPO) on 3 July 2024. The IPO consisted of 5,750,000 units (including 750,000 over-allotment units) at an offering price of US\$10 per unit. The company commenced trading on the Nasdaq Capital Market under the ticker symbol "EURKU" on 2 July 2024.

Eureka Acquisition Corp intends to pursue business combinations with targets that will not be limited to a particular industry or geographic location but will initially focus on Asia.
