Anne-Gaëlle has almost 20 years of experience in the legal profession. Her achievements include working on the set up of master-feeder and parallel structures for major US and UK PE and VC asset managers. She has worked with one of the world's largest independent investment management firms with over USD 1.1 trillion in client assets under management, on the establishment of a Luxembourg private equity alternative investment fund. Anne-Gaëlle also leads the Ogier's ESG initiative in Luxembourg.

Anne-Gaëlle is recommended by The Legal 500 in 2019 and 2020 and as a Key Lawyer in 2022.

She has been a panel member at various industry fora (Luxembourg Alternative Funds for Asian Initiators - a practical guide Hong Kong, June 2018; Private Credit Fund Raising - a practical guide New York, November 2018).

Anne-Gaëlle has become a respected voice in the industry and is a member of several associations including Women in Fund Finance, IBA or ALFI. Prior to joining Ogier, Anne-Gaëlle was counsel - head of the Regulatory and Investment Management department of the Luxembourg office of a French law firm. She has been working for law firms in Luxembourg since 2005 including a stint in Hong Kong and the fund structuring department of a Luxembourg bank.
