Background and experience

 Advising the Viscount of the Royal Court of Jersey on all matters relating to the desastres (bankruptcy) of a local GP and Jersey incorporated company, related proceedings before the English High Court, described by the Court as being of "labyrinthine complexity", and the realisation of assets following trial in the English proceedings in 2021 - *The Serious Fraud Office & Anor v Litigation Capital Limited & ors [2021] EWHC 1272 (Comm)*.
