He has experience in a wide range of commercial litigation matters, including shareholder disputes and contractual claims, including those with cryptocurrency elements.

Before joining Ogier, Romauld had experience as legal counsel in an Oxford-based medical technology start-up company. He then worked as an associate attorney in a leading law firm in Trinidad and Tobago, where he was involved in contentious client work in civil litigation and public / constitutional law. He provided integral work on matters before all tiers of the justice system, including the Judicial Committee of the Privy Council.
