Following PT Ventures' success in those arbitral proceedings in 2019, David continued to act in relation to enforcement steps taken in the BVI.

David has also previously advised the senior secured creditors in the restructuring of the Brazilian Constellation Group, which involved the appointment of the first ever BVI 'light touch' provisional liquidators for the purpose of implementing a debt restructuring. Ogier acted for the Constellation Group itself.
