Rachael Reynolds, global senior partner at Ogier, has been appointed to the distinguished rank of Queen's Counsel.

The title of QC - or "Silk," as it is known informally - is awarded to senior, long-serving and respected members of the legal profession who have demonstrated particular skill and expertise in the conduct of advocacy. It comes at the end of an intensive process of consultation and vetting undertaken by Hon. Anthony Smellie, Chief Justice of the Cayman Islands, and the UK Secretary of State for Foreign and Commonwealth Affairs.

"I'm incredibly grateful to those who have supported and helped me reach this point in my career. It's an absolute privilege to be counted among this group of esteemed practitioners, and a very proud moment for me to receive this special honour," said Rachael, who was also named Advisor of the Year in the Wealthbriefing European Awards 2020 and Litigator of the Year at the Citywealth IFC Awards 2020.
