A SPAC I Acquisition Corp is a blank check company incorporated in the British Virgin Islands for the purpose of effecting a merger, share exchange, asset acquisition, share purchase, reorganisation, or similar business combination with one or more businesses. It is the company's intention to pursue prospective targets that are based in the United States and/or Asia (excluding China) with a focus in the technology, media and telecom (**TMT**) sector.
