The purchase is the fourth hotel Press Up now owns outside of the Irish capital, where the group has an extensive hospitality portfolio. It also owns The Dean hotels in Co Cork and Co Galway, and Glasson Lakehouse in Co Westmeath, which it purchased in 2020.

The Butler Arms Hotel has hosted many famous guests over the years, including Charlie Chaplin,

Walt Disney and legendary financier JP Morgan. More recently, the cast and crew of the Star Wars movies The Last Jedi and The Force Awakens stayed in the hotel in 2014 and 2015 during filming on Skellig Michael.

In a statement, Press Up said: "Press Up Hospitality Group have confirmed the purchase of The Butler Arms Hotel in Waterville, Co Kerry. Located on the seafront in the picturesque Waterville Village on the Ring of Kerry coastline. The 60-bedroom hotel has been in operation for over 100 years under four generations of the Huggard family, who recently made the decision to sell the property. It will be business as usual under the new ownership, with no closures planned and no impact to the current employees."
