The International Stock Exchange (**TISE**) caters for the listing of a broad range of equity securities issued by trading companies, investment vehicles such as open and closed ended funds and real estate investment trusts (**REITS**), together with special purpose acquisition companies (**SPACs**).

Current listings on TISE include a variety of structures and a wide range of legal entities established globally. The range of existing listed investment securities includes equity funds, hedge funds, debt and distressed debt, insurance linked securities, private equity and real estate.

TISE's listing authority, The International Stock Exchange Authority Limited (**TISEA**), is also open to new product lines and structures.

Requirement for a Listing Sponsor
An issuer is required to appoint a sponsor before it can proceed with a listing application. The sponsor acts as an intermediary between the issuer and TISEA and its responsibilities include the preparation and submission of the formal listing application.
