Governance reform

Good governance is the backbone of successful sports organisations. Ogier provides comprehensive governance advice in Ireland by assisting national governing bodies, clubs and associations in establishing robust governance frameworks, including constitutional, disciplinary and other policy reform to ensure procedures are effective.

Our guidance supports sports bodies in achieving high standards of transparency, accountability, and integrity, fostering trust among stakeholders. We also provide advice in implementing change, including presenting to Annual and Extraordinary General Meetings to ensure proposed reforms are passed.

Sports hearings and arbitration

Sports hearings and arbitration are key features of sports law. 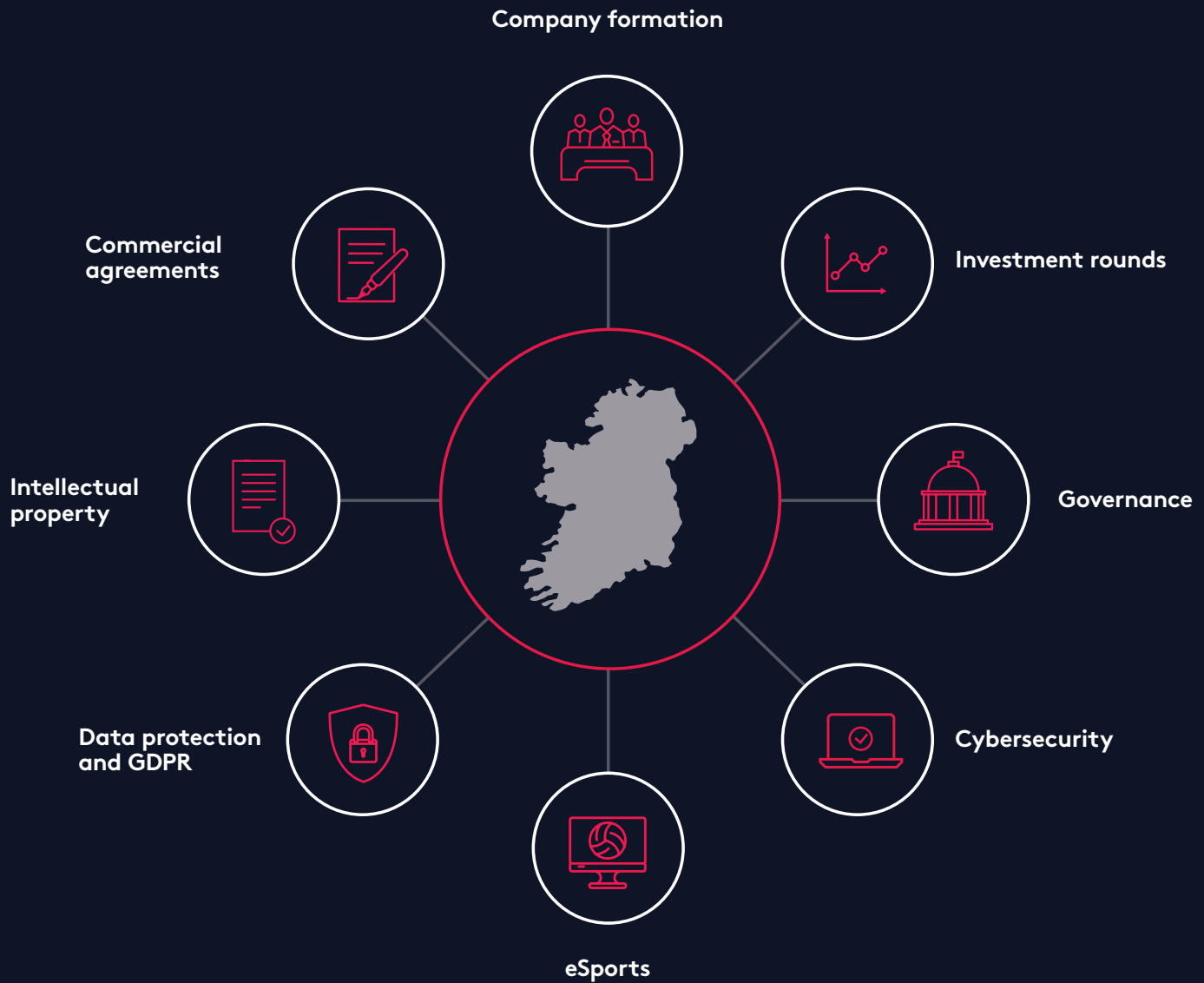

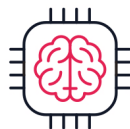

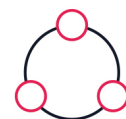
