Ogier advised longstanding client Gazit Globe on its €1.45 billion acquisition of Atrium European Real Estate Limited (AERE) – the first ever take-private by way of a Jersey statutory merger.

The ground-breaking transaction, which involved the cash acquisition of the entire issued share capital of AERE not already owned directly or indirectly by Gazit or its affiliates, set a new precedent for the mergers and acquisitions of Jersey listed companies.

Working closely with lead counsel Kirkland & Ellis, Ogier guided Gazit through the novel approach to the transaction, including the shareholder approval mechanics (which involved a “majority of the minority” requirement), shareholder and creditor objection rights and the Jersey regulatory position.
